#### Notes on 2023:

In 2023, our vet staff grew to include a third full time veterinarian in Q3-Q4, and reduced to two full time veterinarians plus one part time vet at the end of Q4. Our new client numbers continue to increase. Lauren, Dr. Lenore, and Emily attended HSUS Animal Care Expo in New Orleans.

Returns normalized to pre-COVID numbers.

Adoptions dipped slightly. Foster families dipped to 234. These numbers are aligned with national numbers, approaching 2019 numbers (pre-covid).

In Q2, Lauren started a regular gathering of rescue leaders to find ways to partner and help one another out. They learned from one another and continue to stay in touch with regular meetings. This gathering has been called "Canine and Cats Coffee Klatsch."

We held our 2nd annual Wags and Whiskers at The Tinsmith, including a silent and live auction, wine pull, tarot card readers, caricature artist, 50/50 bead game raffle, and presentation.

Melissa Burchell-Dogra continued to serve as our Board President with an extended focus on growing toward being a policy board. Mia Hicks and Lauren Toler joined our board, while Steph Tauscher and Sara Wiesner stepped down.

Jorge Melara continued to serve as Underdog's staff trainer for dogs. Steph Tauscher joined the dog behavior team as a volunteer for part of 2023. Susan Shepanek continued to offer support to cat adopters and fosters, receiving help from Holly Sutcliffe at the end of 2023.

In early August, we acquired a mobile veterinary clinic from The Fix is In. This nonprofit organization, which had provided spay/neuter services throughout the state of WI for the past several years, ceased veterinary operations and was looking to sell their mobile clinic. We bartered to acquire this. We paid \$5000 and promised that over the following 5 years, we'd provide 1550 free spays and neuters for outdoor felines. We visited 8 locations and provided services for 231 animals.

We hired Tarek Said as our first paid Development Director. He worked to establish a strong base for future fundraising. We purchased Donor Perfect software (discontinuing our use of DonorSnap). This new software allows us to send immediate donor acknowledgements and improve our user experience (and donor experience). We continued our capital campaign, adjusting it to our "Forever Home Campaign" to generate new interest. In late August, we closed on our new property at 2508 S Stoughton Rd in Madison. This will serve as our veterinary clinic and headquarters. Construction permits were submitted, and demolition was completed.

We spent Q2-4 preparing for the launch of our first shelter/rescue software, Shelterluv.

We ended our year by celebrating our volunteers and having our holiday gathering at the Monona Bank Riverrink.
